FLTF URGENT MITIGATION GUIDELINES

FLTF started developing its urgent mitigation guidelines on 28th November 2023.

One of the core mandate of the Fish Levy Trust Fund is to provide supplementary funding on urgent mitigation to persons engaged in fishing and fishing-related activities.

These guidelines will reduce loss of life and property by minimizing the impact of disasters. This will begin with the Fund identifying common natural disasters and vulnerabilities that affect the fisher folk.

Partnering for Sustainability

FLTF ON GOVERNMENT INVESTMENT MANAGEMENT INFORMATION SYSTEM (GIMIS)

The National Treasury developed the GIMIS an end-to-end automated platform for preparation, submission, analysis and approval of State Corporations budgets. The system allows for the submission of monthly, quarterly and other statutory reports.

FLTF has now been mapped in GIMIS and officers were trained on December 18th 2023 to comply with the National Treasury circular. This will be valuable to the Fund as we commence the preparation of the Annual budget for the financial year 2024/25 and the medium term.

WORLD FISHERIES DAY

World Fisheries Day is celebrated every year to raise awareness on the importance of fisheries and the role it plays in supporting livelihoods, economies and food security.

On 21st November 2023, FLTF participated in the World Fisheries Day in Liwatoni, Mombasa County. The Cabinet Secretary for Mining,Blue Economy and Maritime Affairs Hon. Salim Mvurya was the guest of honor. 2023 World Fisheries Day theme was "Docking for dignity, the role of port in advancing decent work in fisheries."

Activities organized were: workshops; awareness campaigns; cultural events; and community outreach programs. These aim to educate people about responsible fishing, the impact of overfishing and conservation measures.
