### Our Milestone

As we end the third quarter, we celebrate our accomplishments. On 1<sup>st</sup> March 2024, eight (8) regulations under the Fisheries Management and Development Act were published among them is the Fish Levy Order. This is a great milestone for the Fund for this will help inform its fully operationalization.

### FLTF Productivity Mainstreaming Training

Productivity Mainstreaming is a new performance indicator in the 2023/24 Performance Contracting that entails the development, implementation and adoption of strategies and interventions that enable organizations to measure, manage and improve productivity and ultimately entrench a culture of productivity.

FLTF Productivity Committee was trained on Productivity Mainstreaming by the National Productivity Competitiveness Centre (NPCC) in January 2024.

### FLTF Stakeholder Sensitization

Sensitization of Stakeholders on the Fish Levy Trust Fund mandate is among the PC tasks in the financial year 2023/24. The FLTF will continue conducting public education and awareness by sensitizing a hundred (100) Fish Marketing Cooperative Societies on its mandate. In this quarter, FLTF sensitized BMUs in Siaya, Kisumu, Nakuru and Homabay County.



## Top County Management Sensitization

It was found necessary to conduct public education and sensitize public servants in the relevant counties where fisheries resources are situated. This process commenced in the financial year 2022/2023 and continued in the current year. For this reason, the Fund undertook to hold three (3) workshops to sensitize Top County Management on the FLTF mandate. In this quarter, the Fund sensitized County Officials of the Lake region, Western region, Coastal region and Rift Valley region.



## Quality Policy Statement

## Sensitization of Parliamentary Departmental Committee on FLO

Operationalization of the Fund commenced with the development of the Fish Levy regulations, a process that started in 2020. The FLTF regulations now known as the Fish Levy Order (FLO) was gazetted on 1<sup>st</sup> March 2024.

On 15<sup>th</sup> March 2024, the Principal Secretary Betsy Njagi, led the SDBEF team in sensitizing the Parliamentary Departmental Committee on Blue Economy and Irrigation, headed by Hon. David Bowen, on the recently published eight (8) regulations under the Fisheries Management and Development Act (FMDA) among them the Fish Levy Order (FLO).
